

## Dell Range Grand Opening Sweepstakes (“Sweepstakes”) Official Rules

NO PURCHASE, APPLICATION, OR USE OF SPONSOR PRODUCTS OR SERVICES NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States who are eighteen (18) years of age and older at the time of entry. Employees of Sponsor, prize suppliers, and advertising and promotion agencies, and each of their respective parent, subsidiary and affiliated companies, shareholders, officers, directors, agents, representatives, and employees, and each of their immediate family members (spouse, and parents, children and siblings, and their respective spouses regardless where they live) and individuals living in the same households of the above, whether or not related, are not eligible to enter or win a prize. Each entrant by participating in the Sweepstakes agrees to be bound by these Official Rules and Sponsor’s decisions. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations. Void where prohibited or restricted by law, rule or regulation.
- 2. SWEEPSTAKES PERIOD:** Sweepstakes begins at 9:00 a.m. Mountain Time (“MT”) on September 5, 2023 and will end at 5:00 p.m. MT on September 29, 2023.
- 3. HOW TO ENTER:** To enter the Sweepstakes, individuals must fill out an entry form during the Sweepstakes Period at Sponsor’s branch location at 3220 Dell Range Blvd., Cheyenne, Wyoming 82009 during lobby hours. Limit one (1) entry per person during the Sweepstakes Period. Multiple entries per person are prohibited and will void all related entries.
- 4. DRAWING:** The potential winner will be selected in a random drawing on or about 9:00 a.m. MT on October 2, 2023 from among all eligible entries received during the Sweepstakes Period. The drawing will be done under the direction of Sponsor, whose decisions are final in all matters relating to the Sweepstakes.
- 5. ODDS:** The odds of winning depend upon the total number of eligible entries received.
- 6. PRIZE:** One (1) prize will be awarded, consisting of four (4) tickets (winner and three (3) guests) to the Wyoming vs. Colorado St. football game on Saturday, November 4, 2023. Approximate Retail Value (“ARV”) of the prize: \$100.00. All prize details, including but not limited to, exact seat locations, to be determined in the sole discretion of Sponsor. Tickets are subject to standard rain-check policies and procedures. Winner agrees that game tickets are awarded pursuant to a revocable, nontransferable license that is personal to that applicable winner. Winner agrees not to sell, resell, auction, barter, assign, exchange, place in commerce, transfer, give away, donate, or otherwise convey any ticket that is received as a prize. A violation of these restrictions shall revoke winner’s license, and the tickets will not be honored. All costs and expenses associated with the prize acceptance and use not specified herein as being provided, including but not limited to lodging, transportation costs, meals, beverages, gratuities and other expenses incurred by accepting the prize are the sole responsibility of the winner. Winner is responsible for the payment of all federal, state, and local taxes on the prize. No substitution, cash equivalent, or transfer of prizes permitted except at the sole discretion of Sponsor, who reserves the

7. WINNER NOTIFICATION: The potential winner will be notified by telephone approximately one (1) hour after being selected. If Sponsor is unable to engage in a live conversation with the potential winner within a twenty-four (24) hour period from the first notification attempt, or in the event of noncompliance with these Official Rules, then such person will be disqualified and an alternative potential winner will be selected via a random drawing from all remaining eligible entries. Although Sponsor may, in its sole discretion, choose to leave a message or messages on the potential winner's voicemail service or answering machine, such messages are solely to facilitate live contact within the twenty-four (24) hour period and do not constitute a "live conversation" for purposes of these Official Rules. By entering the Sweepstakes, entrants agree to the use by Sponsor and its designees of their name, city and state and photograph/likeness for advertising, promotional and other purposes, worldwide and in perpetuity, in any and all forms of media, now known or hereafter devised (including and without limitation, the Internet) without additional compensation, except where prohibited by law.

8. LIMITATION OF LIABILITY: By participating in the Sweepstakes, entrants, or, if minors, their parents or legal guardians, agree to release, indemnify and hold harmless Sponsor, prize suppliers, and advertising and promotion agencies, and each of their respective parent, subsidiary and affiliated companies, shareholders, officers, directors, agents, representatives, and employees (collectively "Releasees") from and against any injuries, losses, damages, claims, actions and any liability of any kind resulting from or arising from participation in the Sweepstakes or acceptance, possession, use, misuse or non-use of the prizes that may be awarded. This Sweepstakes and these Official Rules shall be interpreted in accordance with the laws of the State of Wyoming without regard to its principles of conflicts of law and jurisdiction and venue shall be solely within the State of Wyoming. Releasees are not responsible for technical, computer, mechanical, printing, typographical, human or other errors relating to or in connection with the Sweepstakes, including, without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize, the Official Rules, or in any Sweepstakes related advertising or materials; or for stolen, lost, late, misdirected, damaged, incomplete, inaccurate, undelivered, delayed or illegible entries; or for electronic, computer, or telephonic malfunction or error, fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly or are lost for any reason including computer, telephone, paper transfer, or human or other error. If in Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if computer viruses, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Sweepstakes, Sponsor, at its exclusive discretion reserve the right to disqualify any individual who tampers with the entry process and/or void any entries submitted fraudulently, to modify or suspend the Sweepstakes, or to terminate the Sweepstakes and conduct a random drawing to award the prize using all eligible non-suspect entries received as of the termination date. Winners are limited to one (1) prize from Sponsor within any three hundred sixty-five day period. As a condition of entering the Sweepstakes, entrants, or if a minor, their parents or legal guardians agrees that: a) under no

circumstances will entrants be permitted to obtain awards for, and entrants hereby waive all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses; b) all causes of action arising out of or connected with this Sweepstakes or the prize awarded, shall be resolved individually, without resort to any form of class action; and c) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred and in no event shall entrant be entitled to receive attorneys' fees or other legal costs. Sponsor reserves the right to modify prize award procedures.
